RESOLUTION NO. 95-2

RESOLUTION ADOPTING A NEGATIVE DECLARATION AND SPHERES OF INFLUENCE AND MASTER SERVICE ELEMENT PLANS FOR THE EIGHT PUBLIC CEMETERY DISTRICTS WITHIN MENDOCINO COUNTY AND MASTER SERVICE ELEMENT PLAN ADOPTION FOR LEGGETT VALLEY FIRE PROTECTION DISTRICT AND COVELO FIRE PROTECTION DISTRICT

WHEREAS, Section 56427 of the Government Code requires that the Local Agency Formation Commission (LAFCO) of Mendocino County adopt and amend Spheres of Influence according to the provisions of the Government Code; and,

WHEREAS, LAFCO staff has prepared an analysis of the Spheres of Influence of the eight Public Cemetery Districts within Mendocino County; and in conjunction reviewed their Master Service Element Plans; and,

WHEREAS, based upon said study, maps indicating the sphere boundaries of the eight district's are the same as their existing individual Spheres of Influence as adopted in 1984; and,

WHEREAS, the Public Cemetery Districts of Russian River, Covelo, Anderson Valley, Westport-Ten Mile, and Cemetery District of the Redwoods have provided their Master Service Element Plans which are consistent with LAFCO policies; and,

WHEREAS, the Public Cemetery Districts of Mendocino-Little River, Hopland and Potter Valley need to supply additional data for their Master Service Element Plans; and,

WHEREAS, LAFCO adopted the Spheres of Influence for Fire Districts in October 1993, however, the Master Service Element Plans are being separately adopted; and,

WHEREAS, the Master Service Element Plans for Leggett Valley Fire Protection District and Covelo Fire Protection District have been submitted and meet the LAFCO policy procedure requirements; and.

WHEREAS, LAFCO has conducted the required public hearings, as properly noticed, to solicit comments from the general public and from affected jurisdictions regarding proper location of said Spheres of Influence and their associated Master Service Element Plan; and

WHEREAS, a preliminary environmental assessment was conducted and a Negative Declaration finding is proposed for adoption of the Sphere of Influence study project. Reso.No.95-2 Page 2

NOW, THEREFORE, BE IT RESOLVED, that the Local Agency Formation Commission of Mendocino County adopts a Negative Declaration to be processed with the County Clerk for the eight Public Cemetery Districts for the Sphere of Influence study project; and

BE IT FURTHER RESOLVED, that LAFCO adopts the Sphere of Influence boundary for each of the eight Public Cemetery Districts as outlined in the map, as Exhibit A, attached hereto and made a part hereof; and

BE IT FURTHER RESOLVED, that the Master Service Element Plans are hereby adopted for the Public Cemetery Districts of Russian River, Covelo, Anderson Valley, Westport-Ten Mile, and Cemetery District of the Redwoods; and

BE IT FURTHER RESOLVED, that the Master Service Element Plans are conditionally approved at such time the remaining data is provided to the satisfaction of the Executive Officer for the Public Cemetery Districts of Mendocino-Little River, Hopland, and Potter Valley; and

BE IT FURTHER RESOLVED, that the Local Agency Formation Commission of Mendocino County adopts a Negative Declaration to be processed with the County Clerk and adopts the Master Service Element Plan for Leggett Valley Fire Protection District and Covelo Fire Protection District; and

BE IT FURTHER RESOLVED, that each District will be notified of their Sphere of Influence map and Master Service Element Plan approval or conditional approval by receipt of a copy of this Resolution.
