1. CALL TO ORDER and ROLL CALL (Video Time 6:38)

Upon motion by Commissioner Orth and second by Commissioner Gonzalez, Consent Calendar Items 4a-4d, Approval of the August 7, 2017 Regular Meeting Summary Minutes, August and September 2017 Claims and Financial Report, and Resolution No 2017-18-01 Correcting the Final Map for the North of Ten Mile Annexation to Fort Bragg Rural Fire Protection District, were approved by roll call vote:

- **5. PUBLIC HEARING ITEMS None** (Video Time 8:55)
- **6. WORKSHOP ITEMS** (Video Time 8:57)
 - 6a) Workshop for Elk Community Service District (CSD) Sphere of Influence (SOI) Update EO Hinman presented, noting the Municipal Service Review (MSR) was adopted in 2016, and the District has established a District website since that time, as recommended by LAFCo. The District's current SOI is coterminous with the District boundary and the District has requested a modification to include in the SOI two areas identified as being served by the District. EO Hinman thanked Mr. MacMillian, Board President, and Chief Mitchell for their assistance. The District is working with the Mendocino County Auditor-Controller's office to determine ways to address financial reporting requirement issues. Comments and questions were offered by Commissioners Ward, McCowen, Rosenberg, Orth, Hamburg, and Brown.

Items for staff to address:

- Page 1-5, Provide clarification of "Fixed Assets" under Expenses on Table 1-1.
- Summary of MSR Determinations and update of MSR information formatted to reduce duplication.
- Page 1-8, 1.2.6 SOI Recommendation stated with clarification to the change of SOI.
- Consider inclusion of a balance sheet and reserve balance in the document.

Discussion was held regarding the District providing essential services to the community while facing declining capacity to do so. The Commissioners recognized the need for capital funding, personnel, training, and housing options for personnel, as well as the challenges of responding to incidents on the State Highways.

The Commission directed staff to notice the Elk CSD SOI Update for public hearing once the SOI Updates are completed for multiple fire protection service providers.

7. MATTERS FOR DISCUSSION & POSSIBLE ACTION

The Policies & Procedures Committee recommended the following draft policies for discussion and possible adoption. Chair Ward thanked the Committee for their recent increased workload in developing and presenting new policies.

7a) Annual Legislative Platform Development for 2017 (Video Time 28:28)

EO Hinman presented. Comments and questions were offered by Commissioners Brown, Ward, McCowen, McNerlin, Gonzalez, Orth, and Doble.

<u>Items for staff to address:</u>

- Item 3.5, Include the proposed strikeout language: "...and restoration of program funding through State subvention payments."
- Several spelling and punctuation corrections were given to staff.
- Item 5.5 Support collaborative efforts, including consolidation, among agencies and LAFCos that encourage opportunities for sharing of services, staff, and facilities to provide more efficient and cost effective services. Support legislation which provides LAFCo with additional opportunities to encourage shared services.

Commission directed Staff to include the edits and present for adoption at the November 6, 2017 Regular Meeting.

7b) Annexation Tax Negotiations Procedures Update (Video Time 40:25)

EO Hinman presented, updating the Commission on her meeting with County Executive Office staff on August 16, 2017. Comments and questions were offered by Commissioners McCowen, Brown, McNerlin, Doble, Rosenberg, and Hamburg.

Commissioner McCowen pointed out the North of Ten Mile Annexation to Fort Bragg Rural Fire Protection District application (Item 4d of this agenda), as per the included LAFCo Resolution No. 12-13-04 adopted on May 6, 2013, stated in Item 6a "Upon completion of the annexation, no property taxes will be transferred to the Fort Bragg Rural Fire Protection District," which meets the requirements of the State Code Section. However, he questioned if tax negotiations occurred between the agencies and if the Board of Supervisors was ever made aware of the process. EO Hinman confirmed that her research did not produce adopted resolutions from either party.

Items for staff to address:

- Within the proposed new policy, the following edits were requested: "process" to "tax exchange agreement," "occurring" to "proposed."
- Extend distribution to each agency affected and the Board of Supervisors in its entirety.
- Within the proposed notification letters, the following edits were requested: "commence" to "complete" "we" to "LAFCo" and some slight sentence structure edits.
- Consider response templates for the affected agencies to notify LAFCo of a commencement of discussions and the results of the negotiations.

7c) Budget Adjustment Policy (Video Time 1:00:25)

EO Hinman presented the recommended draft policy, developed by the Policies & Procedures Committee and reviewed by legal counsel. No comments or questions were offered by Commissioners.

Upon motion by Commissioner Brown and second by Commissioner Gonzalez, the adoption of Resolution No. 2017-18-03, Budget Adjustment Policy, was approved by roll call vote:

- ° City of Fort Bragg public noticing requirements have led to scheduling of public hearing to the November 6, 2017 Regular Meeting.
- ° Mutual Water Companies Profiles have been initiated.
- ° Brooktrails CSD MSR/SOI update has been drafted and provided to the District for collaboration.
- ° Fire District SOIs are continuing around the priorities of fire season. Albion Little-River workshop is proposed for the November 6, 2017 Regular Meeting. Piercy, Leggett Valley, and Long Valley Fire Districts require coordination of further map developments regarding the three Spheres of Influence.

Chair Ward noted the new GIS Contract has been signed and finalized. He also noted the Ukiah Valley Conference Center contract renewal for office space rental has been received and will be itemized for approval in November.
